## A year on - has enough been done?

It is one year on from the first of two major Ōmārama Stream flood events which left considerable damage in its wake.

On the night and morning of July 18/19 last year and again on August 6 heavy rain forced the Ōmārama Stream out of its bed at the bridge and to chart its own new course to the Ahuriri River.

Environment Canterbury river engineers said the flood event of July 18 was the highest ever recorded flow at Wardells Bridge across SH8.

Although much work has been done upstream of the bridge to reduce the risk of a repeat of the damaging flows, those downstream are wondering if enough work has been done there by the agencies tasked with the job.

After last year's floods concerns were raised that planned stream maintenance work had fallen behind and that ECan, which is responsible for the stream work, had not done enough to maintain an effective channel below the bridge to reduce flooding risk to properties there.

Subsequently, in November, a meeting was held between ECan's Ōmārama Stream Rating District ratepayers and ECan staff to discuss a scope of work and how it would be funded.

The agreed scope of work included clearing blockages in-stream, channel improvement, repair to the damaged stopbank and preventative maintenance of willows threatened the flood carrying capacity of the stream. It was estimated it would cost between \$70 and \$100,000 to complete the work.

The plan was to carry out the work early this year on the Stream and flood banks below the SH8 bridge to mitigate flooding risk to adjacent properties in the township. Other agencies have also been involved in carrying out remedial work.

Last week, the Ōmārama Gazette contacted ECan and Waka Kotahi NZ Transport Agency to ask what had been completed and what more needed to be done.

As the agency responsible for state highways, Waka Kotahi is charged with the maintenance of the SH 8 bridge across the Ōmārama Stream - Wardells Bridge. Coastal Otago senior network manager Chris Harris told the Ōmārama Gazette all "reinstatement work" at the bridge had been completed.

"This included, tree removal, the repair of scour damage on the true left bank and rock armouring.

"We will be returning to re-apply herbicide to the tree stumps, otherwise our work is complete," Mr Harris said.

Last month, in the Waitaki District Council assets group report to the Council Activities meeting, assets operations manager Josh Rendell said several assets team officers were working with ECan on flood prevention in Ōmārama to protect council infrastructure and to make sure "more appropriate flood mitigation measures are in place as soon as possible. This is an Environment Canterbury-led project, with Waitaki District Council being one of many stakeholders," the report said.

The council-owned Ōmārama wastewater treatment plant was among the assets which sustained some damage in the event. Others included the golf club road and the walkway.

Stream ratepayers spoken to by the Ōmārama Gazette last week expressed concern that despite the programme of work agreed to in November not enough had been done to prevent flooding if there was to be a repeat of last year's events this winter.

However, on Friday, at the same time as the Ōmārama Gazette received answers to its questions, the ratepayers said they also received an email telling them the remainder of the planned work would be completed by the end of this month.

The Omarama Gazette asked ECan what had been done, what was still to be done and when ratepayers could expect that to be completed.

ECan Rivers manager David Aires said that by March the trees along the eroded stopbank had been removed.

"These were removed using an excavator and stacked on Waitaki District Council land, with prior approval. While the machinery was on site, we skimmed the gravel island adjacent to the bank and stockpiled approximately 730m<sup>3</sup> of gravel on WDC land, again with approval.

"This material has been earmarked for the potential construction of a bund upstream of the bridge," Mr Aires said.

"The intention is to use some of it to repair the stopbank and to build a bund at the State Highway bridge. We are currently in discussions with other parties to determine the best option for these works, in order to prevent flooding and protect existing infrastructure. As yet there is no agreed start date, or date for moving the gravel."

He said the gravel stockpiles would have "little effect" on stream flows should there be repeat of last year's high stream levels.

"In a flood of similar size to last year, water would already be flowing towards the golf course from further upstream. For an event that size, the gravel stockpiles would have little effect," he said.

"As per usual, increased flows are expected in the stream heading into winter.

"Since July 2022, the stream has naturally shifted into a historic channel on the true left of the flood plain and this is now well established, with evidence of habitat for aquatic life, including sockeye salmon spawning beds. We have put a plan of works together to remove low tree limbs, saplings in the stream bed and limbs crossing the river. Removing trees which are at risk of catching debris will open up the stream bed, enabling unimpeded flow."

"The Department of Conservation and Central South Island Fish & Game have both been consulted and we are currently engaging with Te Rūnanga o Moeraki. We hope to start works within the next month. The rebuild of the damaged stopbank will be completed in late spring/early summer, as it is still currently functional."

Modelling has been completed to determine the capacity of the highway bridge and discussion between ECan, the council and Waka Kotahi is ongoing, he said.

At the November meeting the [stream] ratepayers agreed to pay \$30,000 for the next two financial years, \$20,000 the following financial year and \$1000 in the 2026-2027 financial year. All ratepayers agreed to fund this as passed by the committee, as per the minutes," Mr Aires said.

The Ōmārama Gazette also emailed questions to ECan councillor Nick Ward because it understands he has been talking to the Stream ratepayers about the rating arrangement. However, it received no response.

# Paying for the right to know - editorial

The 'right to know' is recognised as fundamental to our democracy.

It is a right which underpins the ability of our media here in New Zealand - yes, even in Ōmārama - to operate freely.

It is a right which Sir Julian Smith, former publisher of the Otago Daily Times and director of Allied Press said equated with "an open, informed and healthy democracy" \*.

In that same forward to Karl Du Fresne's booklet promoting media freedom he points out that there are "myriad ways in which media freedom can be subtly undermined".

It is a right that cannot be taken for granted.

Last week, in response to a Local Government Official Information and Meetings Act request made for more background to a recent Waitaki District Council media release about responses to an Alps to Ocean cycle trail survey, the Ōmārama Gazette received this response:

*"I refer to your official information request dated June 13th, 2023, regarding Alps 2 Ocean Trail survey responses and accident/incident reports. ...*

*Council Officers have reviewed and decided to grant your request.*

*Given the amount of resource required to process your request, we have decided to charge for making the requested information available.*

*We estimate that the maximum charge will be **\$990.00 of work [for] 9 hours estimated to collate (first hour free, then \$55 per half-hour, or part thereof) Plus \$412.50 (\$165 per hour for [the] NZCT (New Zealand Cycle Trails) response, [to your] LGOIMA question 2 ) to extract the information you have requested.***

***However, we have already spent more than an hour on this request, so any further work will need to be charged.***

***In total the maximum charge is \$1,402.50.***

*[The Gazette's ] LGOIMA question 2 was as follows:*

*Please supply the "aggregated" and "anonymous" A20 Trail Survey responses as collated by Get Smart system, and available to the Alps 2 Ocean Trail manager, to the questions about trail difficulty, condition of the trail surfaces, rating of trail signage, suggestions for improving the trail experience, rating of information available on the Alps 2 Ocean website, and how many people needed to be rescued or evacuated, from the past season from September 1, 2022 to April 30, 2023.*

*Any unused component of the maximum charge will be refunded to you.*

*For details of how this charge has been calculated refer to Civic Activities | Waitaki District Council (Official Information Enquiries).*

***Before we proceed further with your request, please confirm your agreement to the charge and pay the maximum full amount \$1,402.50.** Once you have agreed to this payment Council will send you an invoice for you to pay. We will send you the information as soon as practicable after your payment. Please note the pricing indicated can be recalculated if you choose to refine or lessen your request.*

*Kind regards..."*

Official information legislation covers government departments, local government and publicly funded bodies. Section 5 of the Official Information Act 1982 says "... information shall be made available unless there is good reason for withholding it."

And, yes, it is in the Act, agencies do have the right to charge "reasonable" costs for

labour and materials involved in making information available. A deposit maybe required and charges may have to be paid in advance.  
And no, I have received no information from that first hour of work referred to in the email.

*"Time spent deciding whether to grant a request is not chargeable, nor is time spent trying to find information which is not where it should be. Charges can be waived if... payment will cause the applicant financial hardship, It would enhance the organisation's public image or it would be in the public interest,"* investigative reporter Amanda Cropp says in her book\*\*

Let's rewind a bit so you know where this began and how it got to this point.

This year the Alps to Ocean Trail celebrated its first 10 years of operation. In May, the council issued this press release "Alps 2 Ocean Cycle Trail survey reveals positive economic impact" celebrating the significant economic contribution the trail makes to small towns and villages along its route.

Undoubtedly it does – this is why Otematata has been lobbying since the day the trail opened to have it re-routed through its town.

So, why would any reporter want to question any of this, risk any adverse publicity and, basically, ruin a good thing for small town businesses.

I can categorically assure you that was not the aim.

The story I had planned was to be well-researched and rounded – a fair, accurate and balanced view - of the difference the trail has made to our community.

Naturally, the press releases have tended to focus on the positives. But even good news stories need balance otherwise it's just puffery – like those photos of those burgers. And there appear to be cracks appearing in that rose-tinted view of our world-famous trail.

In March, Peter Rodwell, of Elderslie, near Oamaru wrote a letter to the editor of the Oamaru Mail in which he says;

"I read with interest your article on February 17 regarding celebration of the A20.

"There are, of course, a number of contrary views and we, the owners of one of the properties that the trail runs through the centre of, are not celebrating.

The state of the trail is nothing less than a disgrace and it has been so for the last 7 months with no repair in the near future in sight."

The responses from Waitaki District Council assets operations manager Josh Rendell and Waitaki mayor Gary Kircher are attached to the letter.

My sources in Ōmārama tell me of concerns here also.

Because of washouts caused by flood events the best part of a year ago, parts of the trail have been out of action for a considerable part of the tourist season. Repairs and maintenance work began on the Otematapaio River and Tarnbrae in May. There was a press release: Update on Repairs and Maintenance wWork.

In the interim there were accounts of some cyclists leaving the trail and finding themselves lost on private farmland trying to negotiate streams and rivers – the Otematapaio River being one – or to find their way back to the road and firm ground. Was there enough information about the state of the trail available and obvious?

Against the reported positives economics for trail communities must be weighed the costs to tax and ratepayers who have spent in the hundreds of thousands to build and repair the trail since its inception. Figures are available here.:

council is, at present, waiting on a decision on a further bid to the latest funding round to pay for more repairs and maintenance as well as to upgrade sections of the trail to make them safer.

Section 4 of the trail between Tarnbrae and Omarama is second on the priority list - the first in priority in the Waitaki District - for safety upgrades once further MBIE funding is granted. Sources tell me, this season with many more using the trail, accidents in our neck of the woods have reached concerning numbers - specifically where the trail meets Quailburn Rd and cyclists ride into loose gravel. Again, from sources, reportedly Alps 2 Ocean trail manager Robyn Hyde and Fire and Emergency New Zealand Otago/ Waitaki group manager Michael Harrison met earlier this year to discuss ways to improve matters, and the Ōmārama Fire Brigade and First Response were asked to collate accident statistics for Ms Hyde. Sources also told me that some trail operators were helping cyclists get emergency medical help without the involvement of the services, and so true numbers would not necessarily be recorded. That concerns within the trail management team were real became evident in Facebook posts asking for people to report any accidents via its website.

Interestingly, health and safety reports made public in council minutes seem to make scant reference to incidents on the trail. One has to assume councillors would need to be briefed on most incidents? They certainly receive regular briefings about accidents at the Oamaru Aquatic Centre and a "near miss" at Oamaru Airfield was recorded in last month's Council Activity Update.

At this point, for myself as a reporter, there are a raft of questions building up alongside the concerns voiced by my sources.

My starting point for the story was the press release and this statement: "The latest New Zealand Cycle Trail Monthly Report Survey received 807 responses from Alps 2 Ocean Cycle Trail users between April 2022 and March 2023, the highest number of survey responses out of all the 23 Great Rides in New Zealand."

What were those responses, I wondered?

"We're thrilled to see such a high level of engagement from Trail users," said A2O Trail Manager Robyn Hyde. "We take all feedback seriously, and we're committed to making the Trail the best it can be. Positive feedback that has been received month on month is centred on praise for the scenery, facilities, and experiences offered by the Trail. The on-road gravel sections, Trail surface and condition are cited as opportunities to improve the overall experience."

The release went on to tout the positive economic impact – citing another section of the feedback data collected in the survey.

On May 29, I emailed the author of the press release and asked for a copy of the full report and the survey responses which had informed the press release.

I was sent a section of the survey report recording the economic data collected – the "Quarterly Economic Contribution to Area". I thanked them for the response and asked for the additional survey responses referred to in the release and received this reply:

"NZCT commissions the survey and we get a Trail Manager's report/summary each month.

"We unfortunately do not have the actual survey results as the records are with NZCT."

I tried again:

"So, to clarify the request.

"I would like to see the responses submitted by A2O trail users in the survey as referred to in the press release:

*"The latest New Zealand Cycle Trail Monthly Report Survey received 807 responses from Alps 2 Ocean Cycle Trail users between April 2022 and March 2023, the highest number of survey responses out of all the 23 Great Rides in New Zealand. The results exceed the benchmarked minimum and targeted feedback responses, which have been set at 300 and 500 respectively."*

*"We take all feedback seriously, and we're committed to making the Trail the best it can be. We're grateful to everyone who has taken the time to provide feedback and we look forward to continuing to improve the Trail for future users."*

*"Positive feedback that has been received month on month is centred on praise for the scenery, facilities, and experiences offered by the Trail. The on-road gravel sections, Trail surface and condition are cited as opportunities to improve the overall experience."*

I have been sent the economic data from that survey, thank you.

The press release refers to "positive responses" and "areas or opportunities to improve". I would like to see both.

I believe, as you say, NZCT commissions the survey, and Robyn and the council get a Trail Manager's report/summary each month.

However, obviously from the material already provided quite specific segments of information can be pulled out of the data collected, it is the reason for conducting the surveys.

This data and response collection from A2O users is ongoing – and as you say it feeds into economic data and improving experience.

It is logical, as trail managers, the council and Robyn have ready access to this and use it to inform decisions and recommendations for public spending.

I look forward to receiving the information requested."

The communications specialist asked the trail manger to respond.

"Robyn, can you kindly request all the survey responses from NZCT and forward onto Ruth."

There outcome was a to-ing and fro-ing, in all over nine days and no answers. There had been staff absences.

On June 6, the day before publication of the June Gazette and a week after my initial enquiry I added further questions to my request and copied in Mr Harrison.

The day after publication on June 8 I received a response from both within minutes of each other, and it was at this point that further limited information was shared.

From Ms Hyde:

"As indicated previously I forwarded your request for the survey responses to NZCT. NZCT have come back to me and stated that due to privacy issues they are not able to release this information to you. Information gathered via a survey comes under strict privacy rules. Raw data/responses cannot be released to the media as apart from other considerations it was not gathered for this purpose, therefore breaching privacy considerations."

She went on to say that since January 2020 about a third - 34% - of all the accidents which happen on the trail happen on section 4. She did not say how many accidents

this represented.

She also said she had met with emergency services to discuss improved access for them as well as additional signage.

I question the privacy assertion. It states clearly to those who complete the survey that: "Unless otherwise stated, all surveys undertaken by organisations using the get smart system collect information on an anonymous basis and the information you provide is made available to these organisations only when aggregated with the information provided by other survey participants."

Here was Mr Harrison's response:

"Fire and Emergency New Zealand has attended a number of incidents along the Alps 2 Ocean Cycle Trail over the last year. This has been expected as the trail becomes more popular and the number of cyclists using it increases.

"Protecting and preserving lives is our purpose, so when we attend an incident on the trail we advise the Alps 2 Ocean team. They can then investigate and take any appropriate action to make the trail safer for cyclists. The Alps 2 Ocean team have been excellent to work with. Through this relationship we've been able to implement ways to improve access for emergency services to isolated parts of the trail.

"We understand the importance of the Alps 2 Ocean to the local economy and want visitors to enjoy their time in the Waitaki. FENZ will continue to work with the Alps 2 Ocean team to ensure the trail remains a great and safe experience for locals and visitors to our district."

Still no numbers.

It did seem likely the stumbling block was supplying information which could be portrayed or perceived as 'negative'. In my experience it seems the closer you get to public information that someone does not want shared the more pushback there is.

When doing the research for the story I was warned to be careful. Visitors to the trail were supporting a lot of businesses; the place is buzzing and thriving. I agree.

And some are also quietly voicing concern about the fall out. There are operators in all sectors - cycle tour and accommodation - who are afraid to make waves about where things are not working.

From this month the council will require commercial cycle tour operators to pay \$5 per head per day for tour groups using the trail.

Who will administer this, how will they verify numbers and how will they decide how it is spent?

On June 13, I lodged the LGOIMA request with the council asking for the information needed to fill the gaps. *[If you would like to see the full request I can email this to you.]* None of this information is private and all should be readily available so as to inform councillors and council staff about the management of the trail. It is logical as trail managers the council and Robyn have ready access to this and use it to inform decisions and recommendations for public spending as well as the public press releases.

And an Official Information Act Request was lodged with Fire and Emergency New Zealand for the accident statistics. *[If you would like to see the full request I can email this to you.]*

Apart from acknowledging receipt, The only correspondence since has been the



council's request for payment.

Let me tell you a little about the Ōmārama Gazette financials.

This is an excerpt from an email I sent to council chief executive Alex Parmley and then communications specialist Anna Eisenhut , August 4, 2022, explaining how things worked.

“There is a minimum charge made for advertising depending on the size of the advertisement.

This pays for printing and distribution only.

It also pays for the advertising for local and not-for-profit community groups.

It means the council can be offered a discounted rate for its advertising.

The Gazette receives no grants of any kind.

This is to keep everything independent and transparent.

I am not paid, I work as a volunteer for the Ōmārama community.”

This year, the council has paid the Gazette the per annum local contract advertising rate of \$330 for a year's worth (11) full page advertisements - this is its Ahuriri Link published in each Gazette. It has also, so far this year, paid for two additional half page insertions of the snap, send, solve app advertisement for a total of \$60.

I started with a quote from a newspaperman I greatly admire, Sir Julian Smith.

Let me finish with another from New Zealand writer and historian Michael King.

“The role of the journalist above all else is to disclose, to shed light in hidden places.”

I consider charging what is arguably a large sum to retrieve information the council should already have to hand, and which is actively being used in discussions and decisions, to be a financial obstacle to access to public information and one of the “myriad ways in which media freedom can be subtly undermined”.

Unless you can afford to pay for it you won't get access – is that how democracy works?

It is in the public interest for tax and ratepayers to know how their money is being spent.

It is in the public interest to know more about the experiences of the users of the trail, good and bad.

No-one wants Ōmārama to be the place visitors remember because of an accident even if there is gratitude for the kindness of strangers.

No-one wants to be welcoming the injured and their companions into their hostelrys even if they will willingly offer world-class hospitality.

No-one wants people to return home from holiday to rave about the scenery, their top class guides and accommodation and oh, how wonderful Ōmārama's emergency services are. And they are. We do all want the issues dealt to.

I think we all agree on this.

This morning I paid the council the \$1,402.50 asked for in return for supplying the information. I have a receipt.

Let's see what happens next.

NB I will be appealing the council's decision to the Ombudsman

# Trust Board responds to community queries

While St Thomas's has not yet sold the Otago Foundation Trust Board, that is administering matters, has responded to further questions from the community about the sale of the church.

Last month, the Ōmārama Gazette published the story about the church property going on the market which prompted questions about the true ownership of the building because its build was funded by the community and the church was interdenominational.

As well, there were questions asked about the exact amount the Presbyterian Church had contributed to the build.

The Ōmārama Gazette put those questions to the trustees, who forwarded the matter to the Trust's lawyers for their professional opinion.

On Wednesday, the legal team sent a statement to the Ōmārama Gazette on behalf of the Trust and Presbyterian Church Synod of Otago and Southland.

While the church has not sold – the deadline treaty closed June 23 – the Trust does have the legal right to sell both the land and the building, it said.

“...without documentary evidence to the contrary the ownership of the St Thomas's Church building lies with the Trust Board.

“This is because, at law, a building is a fixture of the land and once a building is attached to the land, it is owned by the owner of the land, not by the person or entity who paid for its construction.”

The Trust Board is governed by the Otago Foundation Trust Board Act 1992 – an Act of Parliament. Under section 14 of Act, the Trust Board as trustees “hold” all Presbyterian parish properties located south of the Waitaki River.

The Act rules on what can and can't be done with these properties.

Before coming to decisions it must identify “the purpose” for which the properties were acquired, and “honour” that purpose, “in accordance with the law”.

St Thomas's Church building was built for ecumenical Christian worship and services in the Ōmārama community, and was supported by the Roman Catholic, Anglican, and Presbyterian churches.

“This will need to be taken into account in determining what happens with the building,” the statement said.

Property title records show that the parcel of land that comprises the property has been in the ownership of the Presbyterian Church since at least 1921 (originally the Otago Presbyterian Church Board of Property and latterly the Otago Foundation Trust Board since 1971).

“In terms of the existence of a Deed of Transfer, the chain of ownership recorded on the Records of Title is evidence of the Property ownership over time ...without documentary evidence to the contrary the ownership of the St Thomas's Church building lies with the Trust Board.”

“Our client is therefore legally entitled to sell the Property on the open market and the proceeds will be held on trust by the Trust Board in accordance with the Act.”

The Trust Board must follow a statutory process when deciding what to do with proceeds, and the St Thomas's Church Management Committee was taking steps

(including obtaining community submissions) to determine how the proceeds should be disbursed. it said.

“The Trust Board will consider any documentary evidence provided to it to support application of the proceeds.

“However, without any evidence to the contrary, the Trust Board is required to exercise its statutory functions under the Act when dealing with those proceeds, and it not free to simply distribute those proceeds in a way that does not accord with the provision of the Act.”

Although interdenominational funding made the build possible and it was intended the church would provide a place for ecumenical services, the Trust “does not accept the assertion that the Presbyterian Church did not contribute toward the construction of the building ... this was a joint undertaking between the Roman Catholic, Anglican and Presbyterian Churches.”

The management committee made the decisions to sell because of falling attendance at church services and because it is no longer financially viable to continue to maintain the building, it said.

“Our clients acknowledge that the community is passionate about St Thomas's Church and the history behind its construction.

“It welcomes any documentary evidence that supports a return of some of the proceeds to the community, but does note the statutory constraints it must operate within.

“Our clients will continue to engage with the community on this process.”



# The St John/Fenz MOU review - July update

Next month, it will be one year since the Ōmārama community gathered to put its case to Hato Hone St John and Fire and Emergency New Zealand for a review of the agencies' 2020 Memorandum of Understanding to include a local agreement for its Fire First Response unit which would allow it to be turned out to all medical emergency 111 calls.

At present, the agreement operates under a trial status and is not formalised.

The review of the MOU has been underway since November. The Ōmārama and Districts Community Co-Response Trust oversees and funds the Ōmārama First Response unit.

Last month, Labour's Waitaki candidate Ethan Reille arranged a zoom meeting with the Minister for Internal Affairs Barbara Edmonds and Minister for Emergency Management/Rural Communities Kieran McNulty so the trust could brief them on the issue. However, neither Minister was able to make the meeting. Instead trust members met with Mrs Edmond's private secretary and Fenz National Manager Response Capability Paul Turner.

Speaking to the Ōmārama Gazette after the meeting, Trust Chairman Lindsay Purvis said, although the group was disappointed not to be speaking to the Ministers' directly it felt it had been able to clearly state its case.

He said he asked Mr Turner why the negotiations within Fenz to settle the part it played in the review of the MOU were taking so long.

The MOU needed to be more flexible and not 'one size fits all' so it could allow first response units up and down the country to better serve their communities, especially rural communities – each of which was different, Mr Purvis said.

He said he pressed home the point to the officials that, despite the fact St John and Fenz had agreed the response model could continue as the enhanced trial status, it was still only a trial and needed to be formalised.

The Trust was told, as far as Fenz was concerned, negotiations within the organisation had made progress and now it was waiting for St John to engage in discussions on the matter and set out its requirements, Mr Purvis said.

At the conclusion of the hour-long meeting it was agreed it would be useful if the group reconvened with a St John representative present to continue discussions.

"We need them both [Fenz and St John] to be there. We are adamant we are not going anywhere. We are not giving up," Mr Purvis told the Ōmārama Gazette.

Meanwhile, the Trust has handed a petition with 796 signatures along with a written submission to Waitaki MP Jacqui Dean asking for Parliament to urge the agencies to formalise the trial response model. In addition, it has asked the Petitions Committee to be allowed to speak to its case. The group is waiting for a hearings date.

Last month, Hato Hone St John Southland-Otago District Operations Manager Pauline Buchanan sent this statement to the Omarama Gazette:

*"Hato Hone St John has recently been invited to provide a submission in response to the August 2022 petition ... Should we choose to make a submission, this will become publicly available on the New Zealand Parliament website.*

*"Work continues to review of the MOU between Hato Hone St John and Fire and Emergency New Zealand. In the meantime, Hato Hone St John remains committed to providing timely access to ambulance services to the people of Omarama and other rural communities across New Zealand and we thank the Omarama Fire First Response Unit for their ongoing support," she said.*

**IN LATE NEWS: Labour's Waitaki candidate Ethan Reille sent this update to the trust on Wednesday. *"Fenz representatives are meeting with representatives from St John today to better understand their position. Once I have an update from them I can organise a meeting with all stakeholders."***

# Meeting will discuss new health hub

A community meeting is to be held at the Ōmārama Community Centre next week to present a proposal for a Community Health and Wellness Centre for the Waitaki community.

The Waitaki Valley Health Trust has historically been responsible for providing medical services to the mid and upper Waitaki.

The trust strongly believed there was an urgent need for a replacement community health and wellness centre to replace the "aged and inadequate" general practice buildings, in Kurow, trust chairperson Jim Jerram said.

"Safety, and in particular privacy of access, within a small community is seen as a priority in this concept."

Dr Jerram said the trust was committed to broadening the scope of the facility and providing a modern purpose-built, future-proofed building that would meet the needs of the general practice and the wider community into the future.

Dr Tim Gardner and wife Juliet Gardner bought the Kurow-based general practice in 2016. "We are in consultation with them at each step in the project process," Dr Jerram said.

The Trust became "landlords" of the premises on land owned by Department of Conservation and vested in the Waitaki District Council, he said.

The project aimed to provide a "multipurpose physical environment to cover the breadth of services necessary to promote health and wellbeing and to dispense health care".

"The medical practice build will be the major, but not only, component, with allied health services, including physiotherapy, counselling, podiatry, ear nurse, district nursing and particularly a community meeting room also being accommodated."

"To be blunt, the existing facility is marginal at best, certainly not fit-for-purpose. It is a collection of old 1960's Catchment Commission buildings... Disability and ambulance access is poor with consulting rooms and offices on different levels.

Practice staff struggle with insufficient rooms and space; poor insulation and lack of adequate heating and cooling; constant maintenance issues (leaking roof, blocked drainage etc)."

"Major upgrades are needed." .

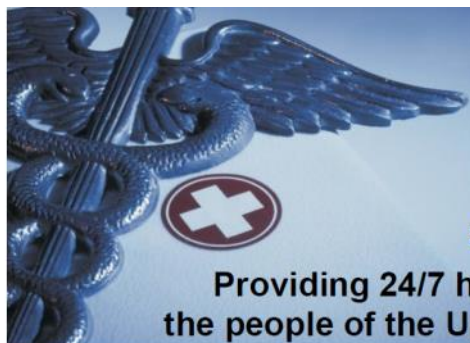
