### We're marking a small step forward

August marks one year since the community, led by the Ōmārama First Response Trust, gathered to put its case to Hato Hone St John and Fire and Emergency New Zealand to have the agencies formalise a local agreement for its Fire First response unit to be turned out to all medical 111 calls in the area and to be able to respond to medical alarm calls.

"While this is still yet to be formalised, we have indicated we are open to developing a more robust process for ensuring Fire First Response Units (FFRU) are considered for some incidents in a FFRU area – especially for incidents involving vulnerable patients (such as elderly who have fallen) and patients who may be exposed to environmental factors that make them prone to deterioration prior to ambulance arrival. In the meantime, we are continuing to dispatch Ōmārama FFRU to all medical emergencies where it is clinically appropriate and meets the current criteria.

"Like Fire and Emergency New Zealand, Hato Hone St John operates in a dynamic environment, where community needs are changing. It is particularly challenging in

rural areas, and we would like to acknowledge the amazing contribution the Fire First Response Units make as part of our wider response framework," Mrs Buchanan said.

Ōmārama and Districts Community Co-Response Trust chairman Lindsay Purvis said, while he had not had the time to discuss the statement with the trust, he saw it as "a baby step", and a "step in the right direction".

He would like to see more detail about how St John would define the kinds of incidents to which the First Response was turned out to, but this was a start.

He said he agreed with Mrs Buchanan that all services were working in a dynamic environment with changing community needs. which is why the Trust was seeking a change to the MOU.

The Trust would meet shortly to consider the new information, Mr Purvis said.

Labour's Waitaki candidate Ethan Reille arranged the previous meeting. The Gazette contacted Mr Reille last week to ask about progress.

Mr Reille said that he understood Fenz had spoken to St John.

"Fenz officials have suggested that they wish to progress such engagement with Ōmārama First Responders and are currently working on how this will work logistically (who, what, where)."

He said Mrs Edmonds was "fully aware of these ongoings" and he would continue to keep her in the loop.

"I will also continue to advocate for the Trust and work closely with them as we work towards a resolution that has the community's best interests at heart."

The Gazette understands that, early last month, after many months of discussions within Fenz, its deputy chief executive Russell Wood met with St John to ask it to clarify its position and vision for the MOU.

This week Gazette asked Fenz also for an update and to clarify what the position was... would the trial status be formalised in the new MOU?

The Gazette was told to direct its questions to St John.

Fenz specialist response manager Aaron Waterreus said St John was the lead agency for medical responses across most of the country and they made all decisions as to how they triaged patients and dispatched crews.

"Fire and Emergency New Zealand and our brigades operate in a support role, and we will abide by Hato Hone St John's decision. We will be next engaging with the Ōmārama Volunteer Fire Brigade when we are ready to share Hato Hone St John's final decision on the matter," Mr Waterreus said.

The Trust is also waiting to hear from Parliament's petitions committee about when it will get its chance to speak to its submission at an oral hearing.

A spokeperson for Waitaki MP Jacqui Dean, who heads the committee, said the committee was at present seeking further advice on the petition.

### ECan assures stream work is "imminent".

It seems it is taking more time to fulfil promises about completing river maintenance work made to Omarama Stream ratepayers last month than was first envisaged.

Last month, Environment Canterbury said remaining work planned for this year's stream maintenance programme would be finished by the end of July.

The Department of Conservation and Central South Island Fish & Game had both been consulted and it was consulting with Te Rūnanga o Moeraki. "We hope to start works within the next month," - that being July, the ECan statement said.

However, no work has started, so last week the Gazette asked ECan why the delays.

Rivers Manager David Aires said work on the river channel works were "imminent". "We are simply awaiting formal documentation and expect to be able to start within a couple of weeks. The works upstream are being carried out by NZTA and their bridge team."

In response, the Gazette asked why there was a delay with documentation given the work programme was laid out and approved by the ratepayers last November. ECan said the hold-up had "simply been a result of the time and availability of people involved in the engagement process when we are working with multiple partner agencies".

"Staff have also been responding to flood events over the last week."

The Gazette has also verified the work upstream and at the bridge was completed by Waka Kotahi in June.

Last year, two major flood events in July and August caused considerable damage to properties along the length of the Ōmārama Stream and when it flowed along the state highway and through the township.

As a consequence, Omarama stream ratepayers met with ECan in November to

draw up a programme of work at a cost of \$70,000 to \$100,000 with the initial work to be completed before this winter.

The agreed scope of work included clearing blockages in-stream, channel improvement, repair to the damaged stopbank and preventative maintenance of willows threatened the flood carrying capacity of the stream. Subsequently, ECan carried out some work in March. Although much work had been done upstream of the SH 8 bridge to reduce the risk of a repeat of the damaging flows, those downstream were left wondering if enough had been done by the agencies tasked with completing the job there, before winter.

The Ōmārama Gazette has yet to hear from ECan councillor Nick Ward in reply to questions put to him in June discussions he has had with stream ratepayers about the rating arrangement.



### **Community group could enter discussions**

Residents concerned about the sale of St Thomas' church by the Presbyterian Church could set up a small group to work with church authorities to look at various options for the return to the community of any proceeds.

In June, the community was told that while the sale of the property could be imminent, decisions about how the proceeds would be used could take "quite some time", if not "years".

The church went on the market on May 17 with a deadline sale date of June 23 and at that time the Gazette was told three indications of interest had been received. The Otago Foundation Trust Board is the perpetual trustee of Presbyterian properties located south of the Waitaki River and it has title to the property - both the St Thomas's building and the land is vested with the Board.

The St Thomas's Church building was built for ecumenical Christian worship and services in the Ōmārama community, and was supported by the Roman Catholic, Anglican, and Presbyterian churches.

The church management committee has been tasked by the Trust Board to research the "source and intent" of contributions made to the building of the church and verify as far as possible the "underlying purposes" - why funds were given so it can put a case to the Board with recommendations for the dispersal of the proceeds.

In June, the Ōmārama Residents' Association wrote to church authorities saying it wanted it put on record that residents did not want the building sold but returned to the community which had fundraised for and built it, or that funds from any sale be given to back to the community.

Last month, the association considered forming a small committee to work with church authorities and look at various options.

There was "nothing further to report" about the sale at present, St Thomas's Combined Church management committee secretary Lee Kearon told the Ōmārama Gazette on Monday.

The property no longer appears on listings websites or those that note what has been recently sold.

### **Volunteers vital to Coastguard service**

Sometimes it seems the CoastGuard is the forgotten emergency service, former president of Coastguard Mackenzie Lakes Dene Madden says.

And that could be because people wondered just what a coastguard would need to do this far inland.

Yet, in the Mackenzie and Upper Waitaki, the volunteer-run service plays a vital role in water safety rescue and education, he said.

Dene may have recently retired from the position, but he is still working to raise awareness about the volunteer service.

It was in that capacity he spoke to a small group at last month's Age Concern Waitaki coffee afternoon in Ōmārama about his experiences.

In fact, the Mackenzie Lakes Coastguard has about 1200km of 'coast' under its watch, Dene said.

At present there are 25 volunteers who work to safeguard water users and their area stretches from Lake Opuha through to Lake Waitaki and includes the canals and rivers in between.

Dene was a founding member of the Mackenzie-Upper Waitaki service which grew out of summertime camping at Lake Benmore with friends and helping out other boaties using their own boats.

As the numbers of boats on the lake grew to be in the hundreds the need emerged for a more formal service.

In 2009 he approached Cheryl Moffat, Coastguard Southern Region Manager, with a request for help. In 2010 Coastguard New Zealand agreed to form the Mackenzie Lakes unit and work began on recruiting volunteers and raising funds for a rescue vessel. In June 2011, it was made official and the Coastguard Mackenzie Lakes unit was formed. *-Continued over*

Apart from a one-year break, Dene has served as president from 2010 until his retirement earlier this year.

He became an Industry Specific Certificate Coastguard Master in 2014 and the unit's Coastguard Instructor in 2017.

He has also spent 20 years as a Maritime safety officer for Environment Canterbury. The unit operates two boats – a 6.9m Naiad called Meridian Rescue and a 9m Naiad – an ex America's Cup chase boat with 4WD truck - named Mackenzie Lakes.

The unit regularly provides safety boat services for events like the Meridian Twizel Hard Labour Weekend and the Aviemore Classic Sail race, and carries out training exercises with Search and Rescue, including exercises along the waterways adjacent to the Alps to Ocean Trail.

Playing the role it did in rescue operations and alongside other emergency services it was inevitable the volunteers were also called on to help not only with rescues but also to recover bodies, he said.

Not many knew the coastguard unit had played a vital role in helping to fight the Lake Pukaki and Ohau fires – two of New Zealand's biggest wildfires, Dene said. Because helicopters were using monsoon buckets and flying over water the coastguard was employed as a safety boat in case a rescue was needed. The coastguard volunteers put in long, gruelling days battling gales on the lake,

returning battered and bruised from the choppy conditions with the wind at times preventing crews from getting back to land for breaks.

However, despite this, the role the Coastguard played was not given much prominence, Dene said.

As well as employing the service for its lakes and canal inspections Meridian Energy was a staunch supporter of the unit and had donated substantial funds over the years, Dene said.

The unit needed to be 'self-funding' and had to raise money to provide search and rescue equipment, training and support.

And it was always looking for volunteers.

Those who frequented the lakes and rivers in the area might like to think about offering their time to give back to the service , Dene said.

While Dene primarily spoke to the group about his work as a coastguard he also touched on the importance of bowel screening, and talked about his own experience with the deadly disease.

### Another stab at town planning

Last month, Ōmārama was introduced to Waitaki District Council's new placemaking lead Cyndi Christensen at a meeting at the Ōmārama Community Centre attended by 17 people. For those short on time a brief summary of the main points is below. A more complete account follows.

#### Thursday, July 20, meeting outline:

- 17 people, this includes council officers and Waitaki District Council and Ahuriri Community Board elected members attended the meeting to discuss how the Governments' Better off Funding allocated to Ōmārama could be spent.
- No facts were presented about how much the funding is or what it can be spent on. However it seems a considerable sum is tagged for Geopark signage.
- The community was asked to come up with ideas for projects and direct them to the council.
- Locals present at the meeting pointed out that this information had already been gathered on several other occasions.
- Council Placemaking lead Cyndi Christensen said she will visit Ōmārama "every couple of weeks" to 'engage stakeholders' in a review of town centre plans.

#### Here is the long read...

The only observation that could safely be made about last month's meeting to discuss how the Waitaki District Council would spend the Government's 'Better Off Funding' monies tagged for Ōmārama was that confusion reigned.

Seventeen people gathered at the Community Centre to hear about what was being proposed.

That number included Waitaki District Council Ahuriri ward councillor Brent Cowles, Ahuriri Community Board member Mike King, newly-appointed council placemaking lead Cyndi Christensen, urban parks officer Lindsay Hyde and Waitaki Whitestone Geopark manager Lisa Heinz, business owners and Ōmārama Residents' Association members.

The locals who attended struggled with the unclear objective of the meeting and the lack of clear information or facts.

No presentation explaining the funding and its parameters was made nor were any handouts produced.

Discussions were at cross purposes as people tried to find out the actual amount available to be spent, what it could be spent on, and in what time frame, as well as how much had already been tagged by the council for other district-wide projects.

There was frustration expressed over the lack of connection and continuity with the previous community consultation exercises held since 2018 to give the council direction as to the community's list of priorities and ideas - ideas and priorities which seemed to have been shelved or forgotten.

Initially, from statements made in the meeting, it appeared \$240,000 of 'Better-Off Funding' had been allocated to the whole of the valley and that district-wide signage for the Waitaki Whitestone Unesco Global Geopark was also to be paid for from this sum. Despite questions from the floor the total amount tagged for signage was not forthcoming, but it appeared it would be costly. It also appeared it was not something the community could contest.

Ms Heinz said the new signage would be information centre-type communication for geopark visitors.

[Interestingly, the council's approved Better-off funding application, which was made in September 2022, makes no mention of Geopark signage. (The full application is on page 75 of the agenda of the council's June 13 meeting.)

The Geopark only received Unesco accreditation in May this year.]

Later in the meeting, Cr Cowles and Ms Christensen said the amount of Better-off funding was either \$225,000 or \$240, 000 for each of Ōmārama and Otematata to develop their spatial plans.

Ms Christensen said the funding was available to be spent on parts of the spatial plan – "nothing super specific".

Cr Cowles suggested the funds could be used as seed funding for bigger projects as happened in Otematata with the Department of Internal Affairs community-led development programme running there.

Ömārama Station owner Richard Subtil said it was important to know the exact amount of funding available and what it could be spent on.

Ms Christensen said, once signage had been paid for, the amount of funds available was likely to be limited but the community could use what remained for smaller projects.

"The best thing to do is look at smaller projects as steppingstones to get to big projects, use funding as leverage [to get outside funding]. After the signage [is paid for] you won't be left with a whole lot."

Business owners Kay and Hank Verheul said the community had raised concerns about the provision of "better parking" and "better traffic flow" at previous council-run consultation sessions, the last one being in 2020.

"Not much has happened since 2020. We have done this for so many years, there have been lots of promises, we're feeling frustrated, angry and pessimistic," Mrs Verheul said. Mr Verheul asked if the Better-off funding could be used by the council as seed funding to buy the former Rabbit Board land.

The opportunity to use that land to address town centre issues could be lost if it was bought by developers, he said.

Mr Hyde said he was not aware of any discussions between the council and Environment Canterbury about the possibility of buying the Rabbit Board land.

[However, in May 2021 representatives from the Ōmārama Residents Association made the trip to Oamaru to put forward oral submissions to the Long Term Plan requesting the council do just that.

At the time Waitaki Mayor Gary Kircher said the council would "certainly put our hand up" with ECan indicating an interest in buying the Rabbit Board land. He would be attending a Mayoral forum at the end of that week and would bring up the topic with ECan's chairperson. "See if we can start that discussion happening rather than just waiting on them to decide if they might put it on the market or not.".]

#### Back to this meeting.

Mr Hyde said, should the community put forward any ideas now which needed money not provided by the Better-off funding grant, these could be included in the council's next Long Term Plan review so that so money could be set aside for them through that process. The LTP is the council's wish list for a 10-year period. It is reviewed and refined every three years. Each year's budget uses this as a starting point and is finalised as the annual plan for setting that year's rates.

This is a separate process and separate budget from the Better-off funding which is funded from taxes.

Business owners Craig and Glenys Dawson, of GlenCraigs, which would be one of the many businesses affected by any redesign of the council-owned town centre parking area, recommended streetscaping plans and plans to buy the Rabbit Board land be scrapped in favour of developing the reserve land adjacent to the Ōmārama Memorial Hall - what was the former rugby field.

[New designs for traffic flow and carparks in the town centre as well as development of the

Rabbit Board land for extra parking was prioritised in the 2020 master/spatial plan for Omarama ]

"Get that underway because the Rabbit Board thing is going to eat up all the money. We don't want fancy streetscaping," Mr Dawson said.

"We don't want to lose carparks," Mrs Dawson said.

Mr Dawson said it was not signage which attracted permanent residents to a place, rather it was facilities like sports courts.

"We don't know how much money we have to work with," Mr Subtil said. "It wouldn't hurt to have a ball-park figure of how much money we have left. That is the thing we really need to know," he said.

Ms Christensen said the council wanted to understand "what we want in that picture" first and then "pull those things down and cost it".

Cr Cowles said following through with the Rabbit Board land sale involved other parties and was not a simple process.

Ōmārama resident and Volunteer Fire Brigade station officer Maurice Cowie said Fire and Emergency New Zealand had invoked the Public Works Act to permanently secure the portion of the land Fenz Ōmārama occupied and asked why that could not happen here.

Ōmārama Top 10 Holiday Park owner Natalie Beiboer said they had identified a wish for a mini golf course in town which could be built at the campground and used by visitors and locals alike, and could be administered by the Holiday Park.

The Holiday Park leases the reserve land the camping ground occupies from the Waitaki District Council.

It was an idea which found some favour.

"We need to get a win on the board rather than planning and money going down the drain," Mr Dawson said.

Mr Hyde said various amounts had already been tagged in the council's Long-Term Plan for sports and recreation.

For example, in its 2021-31 Long Term Plan, in the year 2031, the council had noted it might spend \$1.761 million on a community sports pitch for Omarama, Mr Hyde said.

Mr Verheul said that since the Residents' Association had already raised funds for a basketball hoop and a skatepark that it would be good to draw up an overall plan to make sure "it all works in together" with other proposals.

Mr Dawson said he believed there would not be a great deal involved in developing a sports pitch.

"Simply having a good flat field. We don't have to be too fancy about it," he said.

Mr Hyde was then asked if a start could be made and the former rugby field could be mowed by the council parks staff on a regular basis. He was non-committal

He suggested a further community meeting to "just drag the ideas out – put them down on post -it notes – throw the ideas around".

Ms Hienz said, ultimately the Community Centre could become a focus with information boards, a picnic area and sports field all in the same place.

She had already been in discussion with the Resident's Association regarding the proposed mural at the Community Centre which could be linked with the geopark signage.

Ms Christensen said developing the area at the Community Centre would make it a place people wanted to spend more time.

She said her goal was to involve the community "in everything".

She would be visiting Omarama "every couple of weeks".

"You guys really need to understand what you want...bite it off in chunks," Ms Christensen said.

Mr King said it was up to the community to come back with ideas " then Cyndi can understand what you want and look at turning it into projects".

The monthly meeting of the Residents Association was held following the meeting.

Council officers did not attend the Association's meeting.

After the meeting, the Ōmārama Gazette's emailed Ms Christensen with a further request for the exact amount of funding available to Ōmārama after the signage was paid for. She referred the Gazette to page 77 of the council's June 13 meeting (see link above) part of the Better-off funding application made in September 2022.

"Details around the work on the Waitaki Story and signage are in very early stages but am sure as we all progress more information can be shared." Ms Christensen said.

#### Background

March 2018

The Ahuriri Community Board held town visioning workshops, for Omarama and Ohau, in Omarama. They were led by independent facilitator Sandra McIntyre. Forty community members, including three from Ohau attended the Omarama/Ohau Workshop. Written comments were also provided from some people who were unable to attend. The ideas discussed were collated and presented to the Ahuriri Community Board so it could advise the council about its long-term planning. The ideas were taken as submissions to that year's Long-Term Plan.

August 2019

As a outcome the council decided to run town Masterplan workshops in August 2019 to develop concept/spatial plans for Otematata and Omarama. They used the same facilitator. From that feedback council planners drew up three options for each town. Submissions could be made on the options which were then fashioned into one masterplan for each town. These were presented to the Ahuriri Community Board at its December 2019 meeting. March 2020 the Ahuriri Community Board ratified the plans and sent them to the Council for its

March 2020 the Ahuriri Community Board ratified the plans and sent them to the Council for its final approval.

Ōmārama people showed up in numbers to that board meeting's public forum. They voiced extreme frustration about the final option chosen by the council because it did not address any of the issues they had raised since day one, but merely side-lined them as 'long term aspirations'. As well, the plan proposed to significantly reduce the number of car parks in the town centre. Despite Ahuriri Community Board members also voicing their reservations about the plan the board voted to recommend that option to the council for its ratification without any amendments.



### **Community Safety Day a hit**

Although not as many as hoped attended last month's Community Safety Day those who did go took advantage of the opportunity to learn some new skills and all reported it was a worthwhile exercise.

The Omarama Resident's Association provided the venue free of charge to Stronger Waitaki' Neighbourhood Support which ran the event and paid for the lunch which was prepared and served by volunteers.

Omarama Police, the Omarama Volunteer Fire Brigade and First Response, Hato Hone St John, Waitaki Neighbourhood Support and Stronger Waitaki representatives and volunteers were present, contributed or gave presentations throughout the day. Sessions were held about fire safety, performing CPR and using a defibrillator and well as general community safety.

### The right to know, part two

Last month, I raised a concern that the Waitaki District Council was insisting I pay \$1,402.50 before releasing any information about survey responses from Alps 2 Ocean Cycle Trail users between April 2022 and March 2023, and other official information about the trail management. The full story is in the July issue.

#### Here is a short update.

Since publication of the story, I have received overwhelming support for my stance from the community and outside the area and many offers to help pay the amount demanded – which I have respectfully declined at this point. Thank you all so much. It was so heart-warming.

And yes, I used the word 'demanded' because, after paying the full amount, I received a reminder notice to pay up. It was fully paid on July 5.

On July 11, I asked the council to please acknowledge receipt of payment and when I could expect the information.

I was then told it wanted to extend the time limit until August 18.

The reason given was because the request was for a large quantity of information and meeting the original time limit would not be possible.

This is information council staff have at hand and use to inform their communications and decisions making, as pointed out in last month's story,

#### So, the wait continues

In the meantime, I have laid a complaint with the Ombudsman regarding the council's decision to charge for release of this information.

# Mural artwork gets the go ahead

This eye-catching concept for a mural designed by Oamaru artist Wicksey (above) has attracted widespread consensus to be given the go-ahead.

An Omarama Residents Association project, the artwork will feature on the concrete wall at the sports courts beside the Memorial Hall and Community Centre.

The association's committee has proposed a couple of tweaks to the original concept –such as the addition of a panel featuring the Ahuriri River.

In the mural the artist has brought together elements for which Ōmārama is renowned; Bill Adam's Merino Sheep statue, sheep farming, the Clay Cliffs, mountains and gliding.

The artwork features the colours of the area; the clay yellow and burnt orange of the cliffs, the warm pinks of the sun playing off the barren landscape of the mountains, and the blues and whites of the sky, water ways and snowcapped peaks.

Bright letters which spell OMARAMA are set against the familiar silhouette of the Benmore range.

The Waitaki District Council's Ahuriri Community Board has given \$6,900 discretionary grant funding to the Residents' Association towards the wall.

# Council's contractor, Corde, have laid the foundations for the new water treatment plant at Ōmārama.

All going well, the plant is expected to be completed by December this year and will provide residents with water that meets the Government's Drinking Water Standards.

Next stages of the project will include work on the bores and installation of electrical systems and switchboards in the treatment plant building. Specialised water treatment equipment is being provided by Filtec.

A special thanks to neighbours who have provided support for this project. More detailed updates on the work and photos will be provided soon as work progresses.

### **Ōmārama Airfield Ltd**

An update from the directors following their board meeting of June 23, 2023

The Year Ahead

The year ahead has a full calendar of courses and events on the airfield. The Ōmārama Gliding Club is stepping up its activity level and part of that is a takeover of the vacant front office in the terminal for use as an administration and operations base. Throughout the season the club will be offering ab initio, introduction to soaring, cross country and alpine pilot courses in addition to hosting the South Island Regionals in January.

Youth Glide also have a busy program with well attended courses being held over the winter and their annual camp in late January.

Kahu Soaring are also in an expansionist mode with additional instructors being on hand for what they anticipate will be a busy season.

Nimbus Drive Development.

The development has been consented and contracts for the civil works will be let in late July with works required to be completed by late October. The 12 lots will go on the market through local agent Gary Sutherland at Tall Poppy in early September. Airfield Users Group.

The board is over the next few weeks forming an Airfield Users Group in order to increase the liaison between the company and airfield operators. The group will provide a valuable platform for identifying and resolving operational and administration issues in a timely manner.

Briefly

Fibre optic cable has been installed to the terminal and distribution from that point, probably by radio, should be available within the next three months.

The board has committed to a web site which will provide information on the airfield, its operators and the local community. The site will include web cams, weather information, and a calendar of courses and events scheduled for the airfield plus links to airfield and community businesses.

The company is replacing aged tractors, upgrading the irrigation supply system and pressing on with the completion of the dedicated winching strip with the aim of it being in use before the close of the season.

The airfield maintenance manager of the past five years, Pete McKenzie, will not be on board for the 2023 - 24 years and the board wishes to recognise the significant contribution Pete has made to the standard and operation of the airfield.

The company has presented its 2023 - 24 Statement of Intent to the shareholders who are the Waitaki District Council and the Ōmārama Soaring Centre Inc. The statement identifies that the company will, over the coming months, be establishing stronger links with the Ōmārama community and Ōmārama businesses as we all put the tough times of the past few years behind us.

### AHURIRI RIVER - LAKE OHAU Possum Control – Poison Warning

Downer wishes to advise that a ground-based possum control operation will be taking place to prevent the spread of bovine tuberculosis (TB). This operation is being conducted as part of the TBfree New Zealand programme.

Area: This operation covers 11.088 ha starting along the western faces of Lake Ohau and extending south until the Henburn Road.

Operation date: August 2023 - July 2024.

#### Poisoning methods used on this operation include:

Potassium cyanide: Possum habitat will be targeted using Feratox cyanide capsules. Feratox will be placed in a non-toxic peanut paste, either inside biodegradable blue bait bags or baitstations made of potato starch or plastic. Bags and bait stations will be attached to trees or posts in suitable habitat.

Traps will be being used throughout the area in conjunction with poisoning methods. The public is warned to take care in these areas and not to remove carcasses or baits. Baits are toxic to people and animals.

#### General warning

- Do not touch poison bait or traps
- Poison bait or carcasses are deadly to dogs and cats
- Watch children at all times
- Follow the advice on the poison warning signs

#### If you suspect poisoning

In the case of a domestic animal being poisoned, contact a local veterinarian
